A taxi or rental car will be provided in case of a family emergency, home-based crisis, or unscheduled overtime. **Advance registration is required.** Visit www.511contracosta.org to download or request a GRH registration form or call 510-215-3035 to have an application mailed to you. GRH is not for college commuters.

ELIGIBILITY REQUIREMENTS

Applicant must:

- Be at least 18 years of age to participate.
- Currently be driving alone to work.
- Have a valid driver's license.
- Own or have access to a vehicle.
- Travel to, from, or through Contra Costa County.
- Select transit service which coincide with commute origin and destination.
- Agree to complete a follow-up survey to determine the effectiveness of this program.
- NOT currently use a commute alternative (public transit, carpool, vanpool, bike or walk).
- NOT be a previous recipient of any 511 Contra Costa and 511 Contra Costa-sponsored program incentives. Some exceptions are permitted.

PROGRAM RULES

- One (1) applicant/incentive per person and per household in any 511 Contra Costa and 511 Contra Costa-sponsored programs. Some exceptions are permitted.
- Incentive approximates a transit commute for a month. Some exceptions apply.
- This is not a subsidy or rewards program.
- Falsifying any information on this application will disqualify you from ALL 511 Contra Costa and 511 Contra Costa-sponsored programs.
- Transit tickets and passes are not for resale. Websites are checked routinely for 511 Contra Costa-issued transit tickets and passes. The reselling of tickets and passes will disqualify you from ALL 511 Contra Costa and 511 Contra Costa-sponsored programs.
- Funding for this program is limited. Transit tickets and passes are available while supplies last.
- 511 Contra Costa reserves the right to make any changes to the program and to the eligibility requirements and program rules without prior notification.
